that the balance of £1,000 should remain in the Council's funds for any further applications for funding in this financial year. The RFO is to write to Edenbridge Community First Responders stating members understand they have received funding from another source to cover the kits since the application form was submitted.

Edenbridge Players and The Forge Singers are to be reminded again that they should apply to other sources including Sevenoaks District Arts Council as the Council, had suggested in previous years. Before further applications are submitted, members will need to receive reassurance that all current policies are in place.

Funding has been earmarked for Hi Kent (Local Registered Deaf Charity). They are to be asked to provide a budget to include what they are proposing to do in Edenbridge.

Nomads Football Club is to be advised that funding has been earmarked pending their cooperation with the Council regarding lease meetings.

Cllr Scholey had reminded members that funding had been allocated in the Capital Reserves Fund for House Project and this funding did not need to come out of the Grants budget. The Grant Application for West Kent Extra was therefore considered as a separate item and members

Resolved: that the £7,500 applied for would be provided from General Capital Reserve Funds.

5. TO CONSIDER THE SERVICE LEVEL AGREEMENTS FOR 2016/17

Members recalled that the Council has two Service Level Agreements (SLA) which have been in place for almost three years now, between Edenbridge Town Council and (1) Eden Valley Museum Trust (EVMT) and (2) Edenbridge and District Twinning Association (E&DTA). The interim reports on progress and spending had been submitted, along with requests for funding for 2016/17. Members were pleased with the interim reports and having considered the funding requests

Resolved: that E&DTA and EVMT SLA

would be extended for a further year and the RFO would include £500 and £5,500 respectively when preparing the 2016/17 budget.
