5. FINANCIAL MATTERS

5.1 Current budget and expenditure update

Members noted the position up to 31 December 2018, and that purchase of a new stock of batteries for torches and megaphones at £18.26 plus VAT following the equipment audit would appear in January figures.

6.1 Exercise Eden

Alex Dawson reported on Exercise Eden held on 30th November, based on a tower block fire scenario, and using the Leisure Centre as a welfare centre and base for forward control. She advised that it had not gone as well as hoped, but had provided useful learning experience and highlighted points for change within the Sevenoaks Emergency Plan. Radio communication from Edenbridge over to Sevenoaks had worked well, with Raynet volunteers operating for SDC.

The planned feed-back meeting had been postponed, as staff had been diverted to work on preparations for Brexit.

6.2 Annual equipment audit

Councillors Layland and Todd, with Robert McKillop, completed this audit in December

6.3 Review of Edenbridge Community Emergency Plan

Councillors Layland and Todd reviewed the Plan last month, and had identified several points of information to update.

6.4 Community Resilience workshop – October 2018

Members noted the Chairman and Robert McKillop attended this workshop in Tonbridge, organised by the Environment Agency and Kent Resilience Forum, to give a joint presentation on

how Edenbridge Community Emergency Plan works, and especially to share this Committee's experience of maintaining resilient communications.

Members noted the annual check of Fist Aid kits was due – Cllr Davison had already checked one, and the Deputy Clerk would check the other.
