12. HIGHWAYS IMPROVEMENT PLAN

12.1 – Verbal update – email from Kent County Council (KCC):

The previous KCC project manager had gone on secondment and their replacement had also left KCC. Therefore KCC will shortly be instructing to look at the Highways improvement in more detail and the first step will be for them to look at the suitability and practicality of highway engineering measures at this location to help address local concerns. This area is not in one of the KCC collision cluster sites and as such they do not have any available funding to progress this theirs elves but they would be happy to prepare an estimate of the fees outlining the potential next steps for members' consideration. KCC will endeavour to get this to the members within the next couple of months at the latest. Whilst KCC appreciate that this would be disappointing, they asked members to accept their apologies that this has not progressed as quickly as they would have liked but hoped that members appreciated that they have to prioritise their programmed-crash-remedial measures (CRM) and local transport plan (LTP) schemes.

Members Commented: If KCC was not contributing any money and not prioritising the members' Highways Improvement Pan (HIP) why had members been asked by them to create the HIP. Members wished to find out how many other Councils' plans have gone forward? Members wanted to know what the KCC priorities were, as they felt may be missing an aspect of the Town Council's situation.

13. SPEED INDICATOR DEVICE (SID) – Verbal update

Members were advised that KCC Highways had given the following information via telephone call on the day of the meeting:

KCC Highways advised that the contractors installing the posts for the portable speed indicator device (SID) had been delayed; this had now been rescheduled for week commencing 27 September 2021. The equipment was already in the depot and it was expected to be operational by early to mid-October 2021.
