The draft Plan says, "all parishes are undergoing a five year rolling programme of local housing needs surveys..... Where a survey shows evidence of need, we will work with the local community..." (2.13). Edenbridge Housing Needs Survey January 2022 had an 18% response rate (higher return than most), concluding an overall need of up to 46 affordable homes: 25 single people, 10 couples and 11 families.

The Town Council reiterates it's response to the Reg 18-part 1 consultation:

Edenbridge already has a high level of housing association/affordable accommodation. Whilst Edenbridge does not support development in Green Belt, in a proven case/need consideration could be given to a small rural exception site.

However, it would expect the existing need to be met by the new development on Four Elms Road and therefore exceptional rural sites and the release of further Green Belt are not currently needed.

Edenbridge would expect existing and future needs to be met by the Four Elms Road development and other future development sites in the town.
